Booth Setup and Hours:

- Booth setup may begin Thursday, the 13th, from 10 am-5 pm.
- Booths must be fully set up by 9 am on the event day, Friday the 14th.
- Booths must remain set up until the morning of Monday, the 16th.
- Vendor products and wares must be in theme with the early pre-1900s era of mountain men, Native American culture or American history.
- Vendors participating in the Mainstreet Legion Park strip are expected to create an immersive, historically accurate experience. This includes booth setup, signage, and overall presentation reflecting the pre-1900s era.
- All period vendors are strongly encouraged to dress in period-appropriate clothing throughout event hours to enhance the authenticity of the rendezvous experience.
- Booths should be designed with a cohesive theme that reflects historical trade, craftsmanship, or lifestyle. Modern materials, branding, and displays should be minimized or concealed whenever possible.
- Failure to meet period presentation expectations may result in reassignment to a non-period vendor area.

Responsibilities and Liability:

- Exhibitors are responsible for providing any services, furnishings, or other items beyond the booth space provided.
- The Whitehall Chamber of Commerce, Town of Whitehall, Western Legacy Center, and their employees or volunteers are not responsible for the safety of exhibits, exhibitors, or their property against theft, burglary, vandalism, or damage caused by fire, water, or other incidents.
- By signing this agreement, exhibitors waive any claims for damages resulting from participation in the event
- It is strongly recommended that exhibitors carry liability insurance for their protection.
- Exhibitors must comply with all rules, regulations, and conditions set forth by the Town of Whitehall, MT Western Legacy Center, Jefferson County Health Department, and the State of Montana to ensure the safety and welfare of all visitors.

- Final booth space selection is at the discretion of the MT Western Legacy Center, though vendors with similar products will be separated as best is available.
